

Privacy Policy

This Policy applies to ComAround websites, services and applications (“Service”) and explains what information we gather from you when you use the Service, how we may use and share this information, and the security approaches we use to protect your information. We will not use or share your information with anyone except as described in this Privacy Policy.

By using the Service, you consent to the collection and use of your information by ComAround in accordance with this Privacy Policy. If we decide to change our Privacy Policy, we will post those changes on this page and revise the “last modified” date on the Policy. Your access to and use of this Service is also subject to your acceptance of the Master Agreement and General Terms.

This Policy focuses on our treatment of information, which is personally identifiable (“personal information”).

Information We Collect and Use

If you register for an account with the Service, you provide us information about yourself, including but not limited to your name and email address, contact details and type of organization.

You may also provide Content, such as articles, videos and other text to the Service. Your Content and metadata about your Content may be viewed by other users in accordance with your settings on the Service. ComAround, ComAround employees and ComAround contractors or agents will not view your Content except: (i) to maintain, provide or improve the Service; (ii) to help you and respond to your request related to your Content, including support requests; (iii) to review and monitor (if we elect to do so) compliance with our General Terms; (iv) as ComAround believes, in its sole opinion, is necessary to comply with or avoid the violation of applicable law or regulation or to cooperate with law enforcement; or (v) as otherwise described in this Privacy Policy.

We receive and store the information you input when registering for our Service, or which you otherwise provide to us in any other manner.

ComAround uses information we collect to operate, maintain and provide you the features and functionality of the Service, to analyze how the Service is used, diagnose service or technical problems, maintain security, personalize content, remember information to help you efficiently access your account, monitor aggregate metrics such as total number of visitors, traffic and track Content and users as necessary to comply applicable laws.

Communications

We use your email address to send you Service-related notices (including any notices required by law, in lieu of communication by postal mail). We may also use your email address to send you newsletters, marketing and promotional materials, and other information that you may be interested in.

Even if you are not a registered user of our Service, if you email us, we may retain a record of such email communication, including your email address, the content of your email, and our response.

Cookies

When you use the Service, we may send one or more “cookies” – a small data file – to your computer to uniquely identify your browser and let ComAround help you log in faster and enhance your navigation through the site. You can instruct your browser to refuse all cookies or to indicate when cookies is being sent. However, if you do not accept **cookies**, you may not be able to use some features of our Service.

Note that certain third party engaged by your employer or email provider (or your email provider itself) may use cookies. The use of such third party cookies is not covered by this Policy. ComAround does not have access or control over these cookies.

Log Files

When you use the Service, our servers automatically record certain information sent by your web browser. These server logs may include information such as your web request, Internet Protocol (“IP”) address, browser type,

referring / exit pages and URLs, number of clicks and how you interact with links on the Service, domain names, landing pages, pages viewed, mobile carrier, and other such information.

ComAround uses third party tools for user assessment and analytics tools, to help understand use of the Service. Many of these tools collect the information as sent by your browser as part of a web page request, including cookies and your IP address. These tools also receive this information and their use of it is governed by their privacy policy and opt out provisions, where applicable

How We Share Your Information

ComAround may share your personal information with other third parties (such as trusted contractors or service providers who host our Service or otherwise support the operation of the Service) who help provide, or support the provision of, the Service to you. If we do this, such third parties' use of your information will be bound terms which are substantially similar to this Privacy Policy as applicable to the services which they are providing for us.

As we develop our business, we may buy or sell assets or business offerings. Customers, email, and visitor information is generally one of the transferred business assets in these types of transactions and we may transfer your personal information in these instances. We may also transfer or assign such information in the course of corporate divestitures, mergers, or dissolution. We will use commercially reasonable efforts to notify you of any change of ownership or control in which your personal information is transferred.

We may share your information with a third party application either with your consent or in a situation where you give a third party access to your Content, information and/or account (for example when you choose to access our Services through such an application). We are not responsible for what those parties do with your information, so you should make sure you trust the application and that it has a privacy policy acceptable to you.

ComAround may disclose your personal information if required to do so by law or subpoena or if we believe that it is reasonably necessary to comply with a law, regulation or legal request; to protect the safety of any person; to address fraud, security or technical issues; or to protect ComAround's rights or property.

How We Protect Your Information

ComAround uses commercially reasonable physical, managerial, and technical safeguards which are designed to preserve the integrity and security of your personal information, once we receive it.

Links to Other Web Sites

We are not responsible for the practices employed by websites linked to or from the Service, nor the information or content contained therein. Please remember that when you use a link to go from the Service to another website, our Privacy Policy is no longer in effect. Your browsing and interaction on any other website, including those that have a link on our website, is subject to that website's own rules and policies.

Your Choices About Your Information

You may, of course, decline to submit personally identifiable information through the Service, in which case ComAround may not be able to provide certain services to you.
